
Further to our letter dated 6 July I enclose a copy of an update concerning the claim against Lehman Brothers Holdings Inc under the guarantee.

We would draw your attention to the following:

- All of the Lehman securities backing Meteor products are included in the special claim process for Lehman Program Securities.
- The bar date for claims under this process is 2 November 2009.
- It is possible for Meteor to submit a bulk claim in relation to all of the securities in our custody without powers of attorney from each beneficial owner.
- We will not be able to exclude part of the holding in respect of any security in our custody from Meteor's bulk claim (in order to allow another party to make a claim). Therefore if you wish to submit your own claim you will have to transfer custody away from Meteor. Transfer requests using the form overleaf or a copy of it must be received at Meteor by 25 September 2009.
- We believe that once the claims process has started (after 25 September 2009) it will not be possible to transfer custody away from Meteor.
- Meteor will continue, for the time being, to fund the cost of legal and professional advice relating to the valuation and submission of claims and will recover this cost against distributions made.

The calculation of the value of the claim is currently in progress. We will notify you of the US dollar value of the claim in due course.
